Revised Boundary point of zone of containment (Map attached)

The containment-zone shall comprise of the boundary as delineated below.

C1 Jhanda Chowk→C2 Bangle Store End, MB Road →C3 Hospital Road →C4 Maa Tarini Shop End →C5 Dharamsala Phatak End →C6 Chowiki Phatak End.

Revised Boundary point of Buffer of containment (Map attached)

The Buffer-zone shall comprise of the boundary as sketched below.

B1- Rail Line End Chowikipada LC→B2-Mundra Vastralaya End → B3-Shia Masjid Front →B4 Garden End→B5 Field End →B6 Bazar Kolkata Front →B7Vishal Back Side Pail Line End.

The remaining part of the Order No. 15824/Emg dt. 28.09.2020 will remain intact.

This order will come into force with immediate effect and shall remain as such until the same is either rescinded or withdrawn.
