Where as the undersigned deriving power U/s 8 of COVID Regulations, 2020 framed by Govt. of Odisha and Sec. 30 & 34 of Odisha Disaster Management Act, 2005 vide this office order No. 15824 Date.28.09.2020 & revised order No. 16075/Emg. Dt.04.10.2020 had declared area in a particular circumference around the location of the case detected positive in Marwaripada area of Jharsugujda Municipality with the following boundary descriptions at "A" as a segment of Containment and the area between the boundary of Containment and an outer line delineated at "B" as Buffer Zone.

Now for the sake of restoration of normal life in both the areas, I Sri Saroj Kumar Samal, O.A.S., District Magistrate & Collector, Jharsuguda order annulment of the impugned order which gave effect to restriction and regulation with regard to Containment and the activities in Buffer Zone. **This order of rescission will take effect from 17.10.2020. All the arrangements made by the administration with regard to supply of essential commodities stand withdrawn. However the measures of prohibition and restriction for lockdown as pronounced in Govt. order No. 5627/R&DM(DM) dt. 01.10.2020 will continue to be in force.**

Boundary point of zone of containment (Map attached)


The containment-zone shall comprise of the boundary as delineated below.

C1 Jhanda Chowk→C2 Bangle Store End, MB Road →C3 Hospital Road →C4 Maa Tarini Shop End →C5 Dharamsala Phatak End →C6 Chowiki Phatak End.

Boundary point of Buffer of containment (Map attached)


The Buffer-zone shall comprise of the boundary as sketched below.




