**ORDER**



In partial modification of this office Order No. 6078/Emg. Dated. 19.05.2020 and on the basis of inquiry conducted by BDO, Jharsuguda, Tahasildar, Kolabira & EO, Jharsuguda Municipality the shop establishments in the building of Big Bazar and Reliance at Jharsuguda are hereby allowed to remain open and operate with immediate effect in the hours allowed for other similar establishments vide Order No.6078/Emg Dated.19.05.2020 i.e. from 07.00 AM to 05.00 PM. The decisions taken thus is in the context that the shop establishments have separate entry and exit, of different varieties and are under separate ownership despite being housed in the same building. However the operation will be subject to the following

1. Two adjacent shops cannot operate simultaneously and they will open on alternative days on mutual arrangement.
2. The owner will ensure physical distancing among the customers and for the purpose they will regulate entry from the gate and carve out circles in a patterned queue with interspersed equidistance between two customers.
3. The shop dealing in clothes i.e. Reliance Trend will not be allowed to make the change room functional for the customers to test the fit.
4. There will be provision for sanitisation of hands of customers both at the points of entry and exit.
5. No commodity will be sold to a purchaser without mask.
6. All the salesmen and staff should put on mask and be provided small sized hand sanitizers for sanitizing their hands at regular intermission.

Violation of terms and condition will not only lead to closure of shop but also invite action under relevant sections of IPC.




