**OFFICE ORDER**

Whereas the District Magistrate & Collector, Jharsuguda is empowered U/s-8 of Covid-19 Regulations-2020 framed by Government of Odisha to take effective measures for containment of the epidemic which has already been declared a pandemic.

Whereas the District Disaster Management Authority has the power to take necessary measures U/s 30 & 34 of Disaster Management Act to prevent the spread of this disaster.

Whereas the objective of the administration is to go for immediate geographic quarantine, social distancing, enhanced active surveillance, ensure testing of all suspected cases and compulsory home quarantining of contact cases and their isolation as per need.

Whereas a case of Covid-19 has been tested positive in Temporary Medical Centre at Ekatali, High School, Jharsuguda, Jharsuguda Police Station and it is necessary to have time and effort for contact tracing up to the last mile and point, so that the scope of transmission is eliminated and the fledging chain is broken.

Now having the perspective of public interest in the background and for the sake of speedy completion of active surveillance in the area of immediate contact and neighborhood, the following area is declared as zone of "containment" & "Buffer".

The boundary perimeter of Temporary Medical Centre at Ekatali, High School, Jharsuguda , where the quarantined inmate has been tested positive is hereby declared as zone of containment. Further there will be an outer circumference and the area intersticed is declared "Buffer".

**Boundary point of Buffer of containment (Map attached)**

The Buffer-zone shall be comprise of the boundary as sketched below.

B1 North Boundary →B2 East Boundary →B3 South Boundary. →B4 West Boundary.

The vehicular movement in totality both in public and private is stopped in the containment zone excluding the vehicles permitted for supply of essential items, medicines, health surveillance, sanitization and other necessary activity to be undertaken by District Administration and to be used by the police for enforcement of Law and Order and conformity to stipulations. In the Buffer-zone movement of vehicles will be permitted for transportation of essential items from wholesale to retail shops. However permission for the purpose will be

accorded by the Collector & District Magistrate, Jharsuguda. The wholesale points if located in the Buffer-zone will remain open from 07.00 AM to 01.00 PM. The supply chain of medicine and other essential items will be kept uninterrupted by the District Administration.

All the inhabitants of the Containment-zone will stay in-door and this is to be followed without deviation. Violation will invite strict penal action. The institutions and establishments in the Containment-zone enjoying exemption of lockdown in the Containment area will remain closed. All Govt. and Private Institutions both in Containment & Buffer zone are closed. The closure and seizure of operation as enunciated in the order of lockdown i.e. No. 7353/Emg. Dated.05.06.2020 will be adhered to and the exemption allowed therein will seize to operate both in Containment & Buffer zone. The following officers will act as Nodal Officers to ensure smooth supply of essentials and sanitization of the Containment-zone.

1. Sri Madananda Seth, Sanitary Inspector, Jharsuguda Municipality - Maintenance of sanitation and sanitization of the areas.
2. Sri Golak Bihari Mangaraj, Tahasildar, Kolabira- Maintenance of Law and Order
3. Dr. Madhulita Sahoo, AD(PHO) DC, Jharsuguda - Health requirement.
4. Overall supervision will be done by Sub-Collector, Jharsuguda
5. Superintendent of Police, Jharsuguda will make necessary arrangement for immediate deployment of adequate police at the points of requirement to be supervised either by Addl. Superintendent of Police or SDPO, Jharsuguda .

#### Contact Tracing

Contacts of the confirmed and suspected cases will be line listed, tracked and kept under surveillance at home for 28 days.

#### Surveillance

The area of Containment will be under active surveillance. CDM&PHO, Jharsuguda will mobilize required work force immediately to conduct the exercise in respect of all the houses in Containment-zone. Supervisory officers will be also named by the CDM&PHO, Jharsuguda at a ratio of 1:4. The active surveillance will start from 11.06.2020 at 8.00 AM in the morning. Since all the families in the area have been provided with mask by the Dist. Administration they may not have any such need. However the visiting teams will be carrying masks with them for delivery at household not having the same. All ILI and SARI case either reported in the last 14 days by the IDSP or ascertained in course of our across-the district exercise will be tracked and reviewed thoroughly both in the Containment & Buffer zone. Swab will be collected from all cases of confirmed contact at the earliest for testing at the designated Labs.

This order will come into force with immediate effect and shall remain as such until the same is either rescinded or withdrawn.
