Revised Boundary point of zone of containment (Map attached)

The containment-zone shall comprise of the boundary as delineated below.

C1 Shiv Temple Chowk→C2 Front End of OPM Girls HS→C3 Back End of OPM Girls HS
→C4 OPM Girls HS Start →C5 Near A Type Well→C6 A Type Ending.

Revised Boundary point of Buffer of containment (Map attached)

The Buffer-zone shall comprise of the boundary as sketched below.

B1 Shiv Temple End →B2 Ghasbadi Field→B3 Middle of E Type →B4 BJP Office Back.

The active surveillance will start from 21.06.2020 at 8.00 AM in the morning.

The remaining part of the Order No.8285/Emg dt. 15.06.2020 will remain intact.

This order will come into force with immediate effect and shall remain as such until the same is either rescinded or withdrawn.
