



**COVID-19 URGENT**

**ORDER**

**Whereas** the signatory of this order has been empowered U/s-8 of Covid-19 Regulations-2020 framed by Government of Odisha to take effective measures for containment of the epidemic which has already been declared a pandemic.

**Whereas** the objective of the district administration is to go for immediate geographic quarantine, social distancing, enhanced active surveillance, ensure testing of all suspected cases and compulsory home quarantining of contact cases and their isolation as per need.

**Whereas** a health functionary at Bagdehi who has closely interacted with many outdoor patients and also conducted health check up of many more outside the hospital has been tested positive and the health seekers were from different habitations of the locality.

Now therefore, it is felt urgent to extend the area already under shutdown i.e the G.P. of Jharmunda (part) so as to include parts of three adjacent G.Ps i.e. Bhimjore, G.Panpali & Naxapali as detailed below. The period of shutdown will be 72 hours further instead of seven days for the entire area i.e. up to 9.00 PM of 27.6.2020.

In this period there will be door to door active surveillance of all the families of the area, compulsory home and institutional isolation wherever necessary. There will be no in and out movement with reference to the area under shutdown. There will be no movement except for essential commodities. All the activities of the area are stopped.
