Where as the undersigned deriving power U/s 8 of COVID Regulations, 2020 framed by Govt. of Odisha and Sec. 30 & 34 of Odisha Disaster Management Act, 2005 vide this office order No. 8285/Emg. Dt.15.06.2020 and revised order No.8794 dt.20.06.2020 had declared area in a particular circumference around the household of the case detected positive at OPM Colony, Brajarajnaragar of Jharsuguda Municipality of Jharsuguda Police Station with the following boundary descriptions at "A" as a segment of Containment and the area between the boundary of Containment and an outer line delineated at "B" as Buffer Zone.

Whereas active surveillance in the containment area in the meanwhile has been saturated and the activity of intervention on our part in the Buffer Zone has reached finality.

Now for the sake of restoration of normal life in both the areas, I Sri Saroj Kumar Samal, O.A.S., District Magistrate & Collector, Jharsuguda order annulment of the impugned order which gave effect to restriction and regulation with regard to Containment and the activities in Buffer Zone. **This order of rescission will take immediate effect. All the arrangements made by the administration with regard to supply of essential commodities stand withdrawn. However the measures of prohibition and restriction for lockdown as pronounced in Oder 9572/Emg. Dt 02.07.2020 will continue to be in force.**

C1 Shiv Temple Chowk→C2 Front End of OPM Girls HS→C3 Back End of OPM Girls HS →C4 OPM Girls HS Start →C5 Near A Type Well→C6 A Type Ending.

Boundary point of Buffer Zone ("B")

B1 Shiv Temple End →B2 Ghasbadi Field→B3 Middle of E Type →B4 BJP Office Back.


