In pursuance of the content of **Para-4** of the Order No.4582/R&DM(DM) Dt. 31.07.2020 of the Special Relief Commissioner, Govt. of Odisha entailing that worship at public places will continue to be closed until 31/08/2020 and that of **Para-12** wherein the Collectors are authorized to impose area specific restriction on activities outside the Containment Zones also, the undersigned acting in consonance with Section of 34(m) of **Disaster Management Act, 2005**, issues the following directions under the cover of this office **Order No.11418/Emg.** Dt.03.08.2020.

- a) This year there will be no observance of Ganesh Puja at any public place nor people in group will be allowed to throng any place of worship of Bighna Vinashak Shree Ganesh.
- b) Similarly there will be no public celebration nor bheth-ghat at public place on the day of Nuakhai, 2020.
- c) Puja of the deity on the day of Ganesh Chaturthee and observance of Nuakhai will remain a private affair to be performed at households only. Such performance again will be limited to immediate family members.
- d) Rituals of puja will be performed at temples by the priests, concerned preceding, post and on the days of both the festivals.
