ORDER

Where as the undersigned deriving power U/s 8 of COVID Regulations, 2020 framed by Govt. of Odisha and Sec. 30 & 34 of Odisha Disaster Management Act, 2005 vide this office order No.10307/Emg. Dt.13.07.2020 had declared area in a particular circumference around the household of the case detected positive in Rangunathpali, GP-Raghunathpali of Kolabira Block with the following boundary descriptions at "A" as a segment of containment and the area between the boundary of Containment and an outer line delineated at "B" as Buffer Zone, *which had been extended further on detection of subsequent cases of positivity.*

Now for the sake of restoration of normal life in both the areas, I Sri Saroj Kumar Samal, O.A.S., District Magistrate & Collector, Jharsuguda order annulment of the impugned order which gave effect to restriction and regulation with regard to Containment and the activities in Buffer Zone. **This order of rescission will take immediate effect. All the arrangements made by the administration with regard to supply of essential commodities stand withdrawn. However the measures of prohibition and restriction for lockdown as pronounced in Oder 11418/Emg. Dated.03.08.2020 will continue to be in force.**

Boundary point of Zone of containment ("A")

The Containment zone shall comprise of the boundary as delineated below.

C1 Uparpada N End→C2 High School Chowk→ C3 Tetel Tal Dharsa → C4 Rangunathpali road Kata SE End.

Boundary point of Buffer of containment ("B")

The Buffer-zone shall comprise of the boundary as sketched below.

B1 Rengalpali Road→B2 Butupali Road→ B3 Village SE End→B4 Paligaon Chowk
→B5 Fortis Chemical Road




