2. The intending Organization/ Architect firm should submit its Technical & Financial bid in individual envelopes within a Single cover superscribing the title "(EOI call notice Number & date), Not to be opened". Any query in this regard can be clarified from the Municipality Office, Brajrajnagar, Jharsuguga.
3. The cost of Security Deposit mentioned should be deposited in shape of Demand Draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Brajrajnagar Municipality payable at Brajrajnagar.
4. Quoted % rates should be quoted clearly in both figures & words with corrections duly attested by the quotationer
5. Pre-Bid queries, if any shall be clarified with the Executive Officer, Brajrajnagar Municipality, Brajrajnagar OR his authorized representative at 11.30 AM on Dt.18.09.2023.
6. The bids received will be opened on **29.09.2023** at 11.30 AM in presence of the agency or his authorized representative if any. If the date of opening falls on holidays, then the next working date will be treated as date of opening at the same time.
7. The quotationer should submit detailed & satisfactory establishment information capable for preparation & supervision of such project.
8. The firm/ institution should have GST Registration Certificate, PAN as well as I.T.C. up to date. No undertaking would be allowed against non-submission of any required document.
9. It would be the responsibility of the quotationer to get the Project duly Vetted from Govt. Engineering College. The structural design should be prepared and certified by qualified structural Engineer as per I.R.C Codes. Required fees for the same will be reimbursed additionally. It would be responsibility of the quotationer to get the DPR duly technically sanctioned by competent authority as per Codes.
10. The documents should be submitted in both hard as well as soft copy for power point presentation.
11. The quotationer should have previous experience of completing at least 01 (One) single reputed work of similar nature having project cost Rs. 2.00 Crore or three work of similar nature having project cost Rs 0.75 Crore under State Govt. /Central Govt./PSU/ULB and having average financial turnover of Rs.30 Lakhs or above in last 3 years.
12. All the proprietor/partners/directors of the organization must have valid Council of Architecture registration.

13. The qualified and appointed firm shall submit complete drawings, designs & documents such as Feasibility report, Plans, Site Plan, Detailed Drawings, Structural Designs, and other services as per requirement (MEP) along with relevant estimates and DPR within 02 (Two) calendar months, failing which work order would automatically stand cancelled without any correspondence.

(i) At the time of submission of Final Plan, Drawing, Site Plan @25%
(ii) After Submission of structural Design and Vetting from Govt. Engineering College (if required) and technical sanction from competent authority @65%
(iii) After completion of tender process @10%
