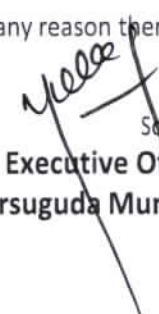

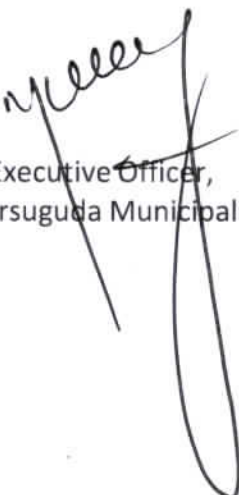

Bid Security/EMD:

The bidder shall furnish, as part of his Bid, a bid security in the amount as shown in Col. 5 of the table of Notice Inviting Tender (NIT) for this particular work. The bidder shall have to deposit the 'Bid Security' in original with the "Officer Inviting Bid" prior to opening of technical bid. The officer inviting the bid shall not be responsible for any postal delay and/ or non-receipt due to any frivolous reasons. Non- submission of bid security within the specified period shall debar the bidder from participating in the on- line bidding system and his portal registration shall be cancelled. His name shall also be informed to the registering authority for cancellation of his registration.
