From all sides in overall rectangular/ circular area. Which may include nearby waterbodies if any.2. Computation of gross volume of legacy waste through typically available software on the basis of drone with DGPS survey maps & historical stereography database collected from NRSC for preparation of detailed estimate/ DPR through typically available software.3. Computation of gross volume in typically available software or actual basic of bio-mined legacy waste on basic of initial, intermediate & final drone with DGPS survey data to facilitate billing of actual execution.4. Conducting the random sampling in the legacy waste in accordance with the prescribed SOP of Govt of Odisha and determine specific gravity or density of legacy waste for weighment.5. Chemical / bacteriology analysis of nearby waterbodies on random sampling basis (before & after the completion of biomining of legacy waste wise.)6. Preparation of DPR after completion of requisite survey, data & maps in line with reverent SOP of Govt. of Odisha & other reverent guidelines of Govt.
