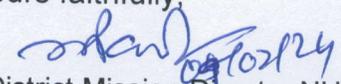

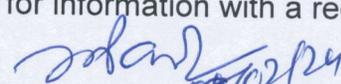

1. Sealed tenders are invited from the interested reputed Travel Agencies/Tour Operators/Private Individuals for hiring on daily/ monthly basis to be used for the purpose of NHM & other programme under Zilla Swasthya Samiti, Jharsuguda. For a period of one year on annual rate contract basis.
2. The tender should be submitted in two parts i.e. Technical bid (Cover-A) and Price bid (Cover-B). Each bid to be submitted in separate sealed envelopes super-scribed as Technical Bid (Cover A) & Price Bid (Cover B) respectively. These two envelopes should be put in another envelope marked as “Tender for hiring of vehicles in reference to adv. no 450”.

**Terms & Conditions**

1. The service provider shall have a valid GST registration to participate in the tendering.
2. Tender Paper Cost of ₹.1000/- (non-refundable).The DD in favour of ZSS MISCELLANEOUS ACCOUNT payable at Jharsuguda and EMD of ₹.10000/- (Refundable).The DD in favour of ZSS MISCELLANEOUS ACCOUNT payable at Jharsuguda, which shall be refunded to unsuccessful bidders without interest after finalisation of the contract.
3. The technical bid are to be opened by the purchasing Authority at the first instance and at the second stage financial bids of only the technically acceptable offers should be opened for further evaluation and ranking before awarding the contract.
4. The Travel Agencies/Tour Operators/Private Individuals will have to submit an Affidavit (On original Stamp Paper of Rs.20/-) in the technical bid with the following clauses:-
  - a) I have not been debarred by any Central/Sate Government organization/Bodies for the last 3 years.
  - b) I have not committed any offence under the Prevention of Corruption Act 1988 or
  - c) The Indian Penal code or any other law for the time being in force, for causing any loss of life or property or causing a threat to public health as part of execution of a public procurement contract.

d) Our organization agrees to a bid by all terms & conditions of the Tender.

5. The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid registration certificate, Insurance certificate, fitness certificate, pollution certificate, valid contract carriage Permit, proof of up-to date tax payment etc. mandatory for plying of vehicle.
6. The driver of the vehicle must have a valid Driving License for drinking light transport, passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
7. The driver should be well behaved and obedient in nature.
8. The monthly rate of hire charge be quoted separately in the general bid information (Excluding fuel & lubricant).
9. The details of the make and year of manufacture of the vehicle ,registration no, mileage(KM covered per liter) and name of the driver ,Driving license No and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender.
10. The department /Office hiring the vehicles shall not be responsible for any damages/loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
11. The hire charges to be paid for monthly basis is final but not include cost of fuel, which is to be paid separately basing on actual consumption and as per existing Government norms. All the expenditure of the vehicles towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyrese & Tubes, Battery etc. will be borne by the bidder.
12. It shall be responsibility of the bidder to provide a good driver and the remuneration of the driver shall be borne by owner.
13. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle /bidder.
14. In case the vehicle do not report regularly, the authority will be at liberty to terminate the agreement without prior notice.
15. The vehicles shall report for duty for minimum of 25 days in a month.
16. In case of emergency, the driver will have to report for duty as per the requirement. No extra payment shall be demanded.
17. Monthly hire charges and reimbursements towards cost of fuel (as per actual) and lubricants (as per govt norms) of selected bidders will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service providers and no advance payment will be made.
18. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
19. If the service provider intends to withdraw the services of his vehicles and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
20. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
21. Contract should ordinarily be awarded to the lowest evaluated bidder whose bid has been found to be responsive and who is eligible and qualified to

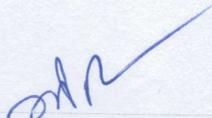

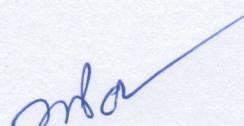

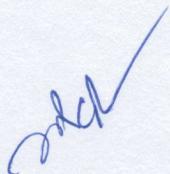
