

ORDER**

There has been steady increase in number of fatalities in Jharsuguda district due to road accidents from 2020 (190) to 2023 (242). The Supreme Court Committee on Road Safety has directed to intensify enforcement against traffic rule violators and to install CCTVs surveillance system (Intelligent Enforcement) at the Black Spots and on Highways as well as in city area of ULB of Jharsuguda District.

In view of the steady rise in fatalities in Jharsuguda district, CCTVs surveillance system (Intelligent Enforcement) and to control traffic and criminal activities in the city, CCTV cameras have been installed at various important places such as Beheramal Chowk, SP Office Chowk, Airport Chowk, Old Bus Stand Chowk, Jharsuguda Town PS Chowk, Sarbahal Chowk and other important places of this district. Arrangements have been made from a control room located in District Police Office, Jharsuguda to monitor the movement of road users. From 08.04.2024, online e-challan will be issued by enforcement team of R.T.O & Traffic Police/ IIC Town Police Station against motorists violating the provisions of the Motor Vehicle Act, 1988. Driving without helmet under section 194(D) of the Motor Vehicle Act fine is Rs. 1,000/-, as per section 194-B(1) of four-wheeler vehicle driver and rider not wearing seat belt fine is Rs. 1,000/-, under Section 194(C), three persons were traveling in a two-wheeler fine is Rs.1,000/-, under section 184(C) using on mobile phone while driving fine is Rs. 5,000/-, under section 184 (A) while jumping red light symbol fine is Rs.5000/-, under section 177 (A) reckless driving fine is Rs.1000/-, under section 184 (B) disobey traffic rules in intersection fine is Rs.5000/- will be levied w.e.f 08.04.2024 in alternate day as per data available from control room for safety of general public & road users in the area of Jharsuguda city until further order.

This order shall be carried out with immediate effect.


