- Earnest Money Deposit:** - The bid must be accompanied by Earnest Money Deposit (EMD) of the amount @ 1% of the bid value as mentioned in the column No-7 of the above table in shape of Fixed Deposit receipt of Schedule Bank/Post office saving Bank account/National Saving certificate/Post Office Time Deposit account duly pledged in favour of Block Development Officer, Jharsuguda.
- Initial Security Deposit:** - All contractors must be deposited 1% of the bid amount at the time of drawal of agreement in shape of Fixed Deposit receipt of Schedule Bank/Post office saving Bank account/National Saving certificate/Post Office Time Deposit account duly pledged in favour of Block Development Officer, Jharsuguda.

5. **Sale and Receipt of Tender Paper:** -The sale of the Bid documents shall also start from dt-22.07.2024 at 10.00 A.M. to dt-06.08.2024 up to 5.00 P.M. The bid documents will be available in the district website <https://jharsuguda.odisha.gov.in> from dt-22.07.2024 at 10.00 AM to dt- 06.08.2024 up to 5.00 PM. and the last date for receipt of Bid documents is dt-06.08.2024 up to 5.00 P.M. Interested bidders may also obtain further information at the same address.

Bid documents in a sealed envelope should be received in the office of Block Development Officer, Jharsuguda through Registered Post / Speed Post only (No tender paper will be received by hand or courier service) and should be super scribed by the NAME OF WORK "(written in Capital Letter) on the Body of the cover. Bidding documents will be dispatched by registered/speed post only. The authority will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same on or before 06.08.2024 up to 5PM.

6. **Date of Opening of the tender Paper**-The Bids will be opened on dt-07.08.2024 at 11.00 A.M. in the Block Conference Hall ,Jharsuguda in the presence of the bidders who wish to attend. If the office happens to be closed (holiday) on the date of receipt/opening of the bids as specified, the bids will be received/opened on the next working day at the same time and venue without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing in the notice board of Panchayat Samiti, Jharsuguda

7. **Additional Performance Security Deposit**- Additional Performance Security shall be obtained from the bidders, when the bid amount is less than the estimated cost put to tender. In such an event, only successful bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the Additional Performance Security as per the following rate as per O.M No-4559 dated 05.4.2021 of works Department, Govt. of Odisha and O.M No-8475/F, dt-5.4.2022 of Government of Odisha Finance Department.

10. The following Documents should be furnished with the tender paper for each construction/completion of various works, failing which the tender is liable for Rejection.

- A) Self attested copy of valid Contractor Registration Certificate.
- B) EMD pledged in favour of Block Development Officer, Jharsuguda
- C) SC/ST Contractors should submit original Affidavit in support of caste certificate and self-attested copy of Caste Certificate.
- D) Original money receipt/Bank Draft towards the cost of Tender paper.
- E) Original Affidavit in support of the authenticity of Documents including EMD etc.
- F) No Relation Certificate with the signature of Tenderer.
- G) Self attested copy of valid PAN Card & GST Certificate
- H) The Bidder(Engineer Contractor) who desires EMD exemption are required to submit valid contractor License and an affidavit sworn in before executive Magistrate to the effect that, they have not availed such exemption for more than three times during this financial year.
- J) Any relaxation/extension relating to EMD/ ISD etc if any declared by Govt. should be furnished with due circular which will be considered during opening of tender documents.

- 11. Engineering Contractors desiring to avail the exemption facility of EMD should submit an original affidavit regarding list of works awarded without submission of EMD/ISD during the current financial year. He should also produce **original contract license** at the time of opening of tender document to make necessary entry to that effect as such facilities are limited to three participation in tender during a financial year, otherwise their tender will be liable for rejection.
- 12. The SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate and self-attested copy of caste certificate, **otherwise their tender will be liable for rejection.**
- 13. Tender paper is liable for rejection in absence of any required documents.
- 14. A bidder can submit only one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular work will liable for rejection of all such tender papers.
- 13. Other details can be seen in the bidding document.
- 14. All type of taxes shall be deducted as applicable. Different dues under provision of law will be deducted during payment.
- 15. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
- 16. Defaulter contractor cannot participate in the bidding process.
