The applications will be scrutinized on 22.08.2024 at 11 AM with the presence of committee members and the applicants and their authorized representatives.

2. Terms and Condition

- i) Only registered Voluntary Organizations can apply.
- ii) The organization should have at least three years of experience of working in the area relating to Animal Welfare activities.
- iii) The organization must not be a profit making organization and must not treat it as a commercial venture.
- iv) It should have properly constituted managing body with its powers, duties and responsibilities clearly defined and laid down in a written bye-law which must include Animal Welfare Activities as one of its constituents.
- v) The voluntary NGO should have audited report of expenditure of last one year by registered Chartered Accountant.
- vi) The organization should have willingness to house at least 250 adult stray cattle.
- vii) The organization shall submit an affidavit to the effect that in the event of its failure to comply by any or all conditions of the assistance the lease agreement automatically be cancelled and it shall refund the whole or such part of assistance as the State Government may decide with interest thereon.
- viii) The land shall continue to stand recorded under Government Khata. The Selected party shall be given permissive possession for a period of 5 years subject to renewal every 5<sup>th</sup> year period. The selected party shall be given permission to operate the Goshala with construction of temporary shed and other ancillary works over the lands the party shall have no claim what so ever over the land regarding right, title and interest.
- ix) The performance of the party and the management of this sector in this field should be satisfactory and successful.
- x) The organization/ body NGO must have a minimum cash balance of Rs.5,00,000/- (Rupees Five Lakh only) for which the party has to submit the photo copy of the Updated Passbook.
- xi) The CDVO reserves the right to cancel the proposal/ agreement any time without assigning any reason thereof.
