Jharsuguda, in exercise of powers conferred upon me by section 115 of Motor Vehicle Act,1988, I, **Ms. Aboli Sunil Naravane, IAS, Collector & District Magistrate, Jharsuguda** do hereby restrict the movement of Heavy goods vehicle.

This restriction will come into force w.e.f. 16.07.2024 to 15.08.2024 (One month).
