Whereas, the Heavy/ Medium/Commercial Passenger carrying vehicles are plying inside the Brundaban Colony of Jharsuguda Municipality area, as there is very narrow road causing traffic congestion. The School going children, senior citizens, old age person are using the road in unsafe condition, unable to walk in the morning and evening and also leprosy inhabitants are also using the same road who are residing in back side of the Society, keeping in views for safety of general public and properties of Brundaban Colony Jharsuguda, in exercise of powers conferred upon me by section 115 of Motor Vehicle Act,1988, I, Ms. Aboli Sunil Naravane, IAS, Collector & District Magistrate, Jharsuguda do hereby restrict the movement of Heavy/ Medium/Commercial Passenger carrying vehicles (having seating capacity more than 9 including driver).

1. Further the loaded/ unloaded goods vehicle weight either of which or a motor vehicle Tractor or Road Roller the unladen weight of any of which exceed (7500 Kgs) are also hereby restricted to ply on the above area.

This restriction will come into force w.e.f. **01.08.2024 to 31.08.2024** (One month).
