- Necessary announcement through mike shall be made in the villages covered under the MLIPs on benefits of pulses and oilseed cultivation, improvement of soil health, Dietary supplements, and water use efficiency etc for a period of 7 days (Jharsuguda, Kolabira, Lakhanpur-2 days each & Kirmira-1 day) & Budget estimate shall be Rs. 0.3 Lakh/cluster". (i.e., total fund provision in Rs.: 1,20,000 including GST)
- As the price is fixed to Rs. 1,20,000 in case of submission of all relevant documents properly by the applicants it will be decided by the committee in the basis of experience in the agriculture sector. The selected organization/agency must have to arrange vehicle (Tata Magic), sound system, flower decoration and display boards (3 nos) for Awareness Ratha.
