Sealed quotations/tenders are hereby invited from interested reputed Travel Agencies/Tour operators or private individuals having valid GST registration certificate for providing 01 No. of vehicle (AC/Non AC)(Bolero/TUV300/SumoGold/Ertiga/Vehicles of Similar Model and segment having same mileage) (Petrol/Diesel) having sitting capacity not more than seven including driver, which shall confirm to the terms and conditions (**Annexue-I**) vide office memorandum No- 22924/F dt- 14.08.2023 of Finance Department Govt. of Odisha for official use in the office of the CDPO, Jharsuguda(Rural) on monthly rent basis for a period of 1 year . The undersigned shall have the right to cancel the quotation at any time without stating any reason.

Conditions:-

- 1) The Service provider shall have a valid OGST registration to participate in the tendering.
- 2) The vehicle must be in road worthy condition, shall not be more than 03 years old from the date of initial registration and must have valid registration certificate, insurance certificate, fitness certificate, valid contact carriage permit, proof of update tax payment etc. which are mandatory for the vehicle owner to participate in the tender process.
- 3) The driver of the vehicle should be well behaved, gentle and obedient in nature and must have a valid Driving license for Driving light transport passenger vehicle and should be sufficiently experience in driving transport passenger vehicle.
- 4) A sum of Rs.5000/- shall be deposited by the intending Bidders in shape of Account payee Bank draft drawn in favor of the CDPO, Jharsuguda (Rural), Jharsuguda payable at any nationalized bank/scheduled bank and be submitted along with the tender papers as security deposit. After completion of tender process, the Account Payee Bank Draft will be returned to the unsuccessful Bidders and the security deposit of the successful bidder will be deposited at this office.
- 5) The monthly rate of hire charges be quoted separately in the general bid format (Excluding Fuel and Lubricants). It is to be noted here that the maximum of ~~Rs.~~Rs.25,000/- per month
- 6) The vehicle must achieve a fuel efficiency of not less than 10 (Ten) Kms per litre
- 7) The detail of the make and year of manufacture of the vehicle, registration no, mileage (KMs cover per liter) and name of the driver with driving license no and period of the validity should be specially provided in the **General bid Information** to be furnished with the quotation (**Annexure-II**)
- 8) The quotation completed in all respect with all required information and documents should be reached to the undersigned through registered post/drop box by dt ~~27~~27.09.2024 by **1 PM** and shall be opened by the quotation committee on dt-~~27~~27.09.2024 at **4 PM** in presence of the bidders or their authorized representatives. Submission of tender paper by hand is prohibited.

- 9) The application form of quotation/tender containing General Bid Information and Terms and Conditions for hiring of vehicles etc. can be obtained from the office during office hour from dt-10.09.2024 to 27.09.2024 on payment of Rs.100/- or can be downloaded from the website www.jharsuguda.odisha.gov.in from dt-10.09.2024 to 27.09.2024 In case the application form is downloaded from the website, the applicant has to furnish a Demand Draft for an amount of Rs.100/- (Rupees one hundred) only towards cost of application along with the application.
- 10) The application will be received through registered post / in the drop box at Block Office, Jharsuguda mentioning in capital letter "QUOTATION FOR VEHICLE"
- 11) The successful bidder will go through a contract agreement with the undersigned with his/her own cost as per Govt. of Finance Deptt. **Letter No-30464 dt-06.09.2019**. The service will commence from 01.10.2024 and shall continue to provide the service up to 30.09.2025 (1 year)



Annexure-I

Terms and Conditions for Hiring of Vehicles

The following terms and conditions must be filled by the successful bidders for providing a vehicle on hire on monthly rent basis.

- 1) The vehicle must be in good condition, shall not be more than 03 years old from the date of initial registration
- 2) The hired vehicle during the period of contract, shall have all necessary valid MV document such as valid registration certificate, insurance certificate, fitness certificate, valid contact carriage permit, proof of update tax payment and DL of the driver applicable all the time. The office hiring the vehicle shall not be responsible for any damaged/loss caused to the hire vehicle in any manner whatsoever the bidder/owner of the hired vehicle shall be responsible for all such litigation
- 3) The hire charges of the vehicle do not include cost of fuel which will be paid separately basing on actual consumption and lubricants as per existing Government norms on monthly basis. All expenditure of vehicle towards repair, replacement of spare parts, lubricating oil of engine, Gear box and different coolant, Tyres and tubes, Battery etc. will be borne by the bidder/owner of the vehicle
- 4) A licensed driver with proper dressing, well behaved, gentle and obedient in nature should be provided by the bidder/owner of the vehicle and salary of the driver shall be borne by the owner of the vehicle.
- 5) The vehicle should be regularly serviced and maintained so as to avoid any breakdown. In case of breakdown of the vehicle for any reason, another vehicle of the same or better model must be provided by bidder/owner of the vehicle.
- 6) The vehicle can not be used for any private or commercial purpose beyond office hours or on holidays. The driver should be ready for office duty at any time. In case emergency the driver will have to report for duty as per the requirement. No extra payment shall be demanded.
- 7) In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other sources
- 8) If the bidder violates any of the terms of the contract, competent authority shall forfeit the entire amount of security deposit and shall cancel the agreement.
- 9) First preference will be given to the BS-IV compliant petrol vehicle.
- 10) The undersigned shall have the right to terminate the agreement upon giving 3 months of notice.
- 11) Monthly hire charges and reimbursement towards cost of fuel (as per actual) and lubricant (as per Govt norms) will be paid in every succeeding month, as per as possible within fifteen days of receipt of bills from the owner of the vehicle and no advance payment will be made.
- 12) In case the service provider intends to withdraw the service of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
