### Terms Condition

1. The intending bidder has to write the name of the markets Toll as detailed in column 2 of Tender Call notice on the envelop and to drop in the tenders box within the stipulated time and date . For each tender the bidder has to bid separately.
2. The bidders has to quote their rate, the maximum amount quoted rate will normally be accepted and after finalization of the process the bidders have to deposits the amount within 07 (seven) days and execute the agreement thereof.
3. No installment will be allowed for deposit of the accepted amount .In case of non deposit of the said amount within the stipulated period the EMD will be fore fitted and the party will not be entitled to collect the tax from the Market/shop etc.
4. On finalization of the bid, the party will be entitled to collect the amount at the prescribed rate of the municipality after signing of Agreement. On deposit of entire bid amount if the party is found to go beyond the clause of the agreement, the orders so issued will stand cancelled and the deposit amount will be forfeited.
5. If any sort of holding tax, license fee shop rent etc. found pending on the name of the bidders or his/her family members the tenders will not be honoured. In such a case the EMD will be fore fitted.
6. The authority is not bound to accept the bid quoted with highest amount .The authority reserves the right to cancel any or all the tenders without assigning any reason thereof.
7. If required the authority reserve the right to insert any other clause or condition in the agreement subsequently and the bidders will have to obey the new condition.
8. The bid amount equal to or less then the off set price will not be accepted.
