1. The bidders have to submit their tenders in separate sealed covers (i.e. **Cover "A"- Technical Bid & Cover "B"- Price Bid**). Both the covers should be put into a third **Cover "C"** which must be super-scribed as "**Tender for "Supply of "GAZELLE HB VARIANT TEST MULTIPACK CARTRIDGES" and Tender Reference No. 3334**".
2. **The Cover "A" (Technical Bid) should contain as follows:**
 - a) Checklist with details of the documents enclosed in **Cover "A"** (As per **Annexure - I**) with page number. The proposal must be complete in all respect, indexed, pages numbered and spiral bound. Each page should be numbered and signed (in full) by the authorized representative.
 - b) Manufacturing unit / supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration about this by a **Notary Public**.
 - c) EMD **Rs.3,00,000/-** (Rupees Three Lakh only - Refundable) in shape of Bank Draft / Bankers Cheque in favor of ZSS Non NRHM Fund, Jharsuguda payable at Jharsuguda.
 - d) Tender Paper Cost **Rs.5,000/-** (Rupees One Thousand only – Non-refundable) in shape of Bank Draft / Bankers Cheque in favor of ZSS Non NRHM Fund, Jharsuguda payable at Jharsuguda.
 - e) Technically Specification of Item (s) as per the format (**Annexure – II**).

 - g) Copy of organization Income Tax Return Acknowledgement for the (**Assessment Year 2022-23, 2023-24 & 2024-25**)

 - j) Performance Statement during the last 01 years towards proof of supply of similar items to any Govt./Corporate/PSU Hospitals in India. The copy of

certificate from the user should be furnished in support of the information provided in the performance statement.

- k) Leaflet / Technical Brochures of the products / item offered.
- l) They should quote the rates for individual items inclusive of insurance, packing, forwarding, freight (door delivery) and exclusive GST (if any) and should submit a self-declaration about this.

The purchaser, at his discretion, will in such case, exercise the right of revising the price at any stage so as to confirm to the controlled price or MRP as the case may be deleted.
