The undersigned shall have the right to cancel the quotation at any time without stating any reason.

- 1) The vehicle must be in road worthy condition, shall not be more than 03 years old from the date of initial Registration Certificate, Insurance Certificate, Fitness Certificate, valid contact carriage permit, proof of up to date tax payment etc. which are mandatory for the vehicle owner to participate in the tender process.
- 2) The driver of the vehicle should be well behaved, gentle and obedient in nature and must have a valid Driving License for driving light Transport Passenger Vehicle and should be sufficiently experience in driving transport passenger vehicle.
- 3) A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank draft drawn in favour of **Block Development Officer, Laikera** payable at any nationalized bank/scheduled bank and be submitted along with the tender papers as security deposit. After completion of tender process, the Account Payee Bank draft will be returned to the unsuccessful Bidders and the security deposit of the successful bidder will be deposited at this Office.
- 4) The monthly rate of hire charges be quoted separately in the general bid format (Excluding Fuel and Lubricants).
- 5) The vehicle must achieve a fuel efficiency of 10 Kms per liter.
