

The sealed quotations so received upto 5.30 PM of 28.3.2025 will be opened by the Tender Committee at 11.00AM on 29.3.2025 in presence of quotationers or their authorized representatives. The quotation received beyond the stipulated date and time will be rejected summarily.

Terms & Conditions

1. The water tanker vehicles should be in good running conditions and will be ready to attend the supply of drinking water works daily basis.
2. The charges of fuel required daily will be borne by the owners.
3. The log book of the vehicles(Tractor) will be maintained every day by the driver and got signed by the villagers, concern Ward Member/ AWW/ASHA and also geo tag in note cam Camera every day when supplying water to the villagers.
4. The driver should be in sound health and good behavior.
5. The vehicle owner should not refrain himself/herself for supply of drinking water after obtaining supply order. If needed one month notice should be given.
6. The vehicle owner should mention rate per tanker including all payments in the prescribed format.
7. The Quotationer shall offer rate per trip supply of water through Tanker in the enclosed format by the stipulated date and time.
8. The Quotationer will deposit Rs.500/- towards Tender cost with the Cashier of this office and tagged the copy of money receipt with the Tender paper else the Tender Paper will not be considered .
9. The date of commencement for supply of drinking water through tanker is 01/04/2025 and the date of completion is 30/06/2025.
