

1. The last date of submission of application(s) is **27-05-2025 up to 5:00 (P.M)**. No application will be entertained / considered after due date & time as mentioned above.
2. Date of opening of applications on **29-05-2025 at 11:00 A.M.** in the **District Excise Office, Jharsuguda.**
3. All the application(s) received within the stipulated period will be opened at **11:00 (A.M.)** on **29-05-2025**. If the day will be declared as a Govt. Holiday, the applications will be opened on the next working day as per the scheduled date and time. Delay in postal delivery shall not be taken into consideration. The applicants are requested to superscribe on the sealed cover as "**Application for Auction of Vehicle vide Regd No._____**". No application will be received by hand.
4. Application for the vehicle should be submitted in a single sealed cover for each vehicle. Each application must accompany with the amount of **Earnest Money Deposit (E.M.D) Rs.1,000/- (Rupees One thousand) only** in shape of **Account Payee Bank Draft** in favor of **Superintendent of Excise, Jharsuguda** payable at- **SBI Main Branch, Jharsuguda**. No application will be considered valid without payment of the Earnest Money Deposit (E.M.D). Bank drafts will be returned to the unsuccessful applicants only after finalization of the bid process.
5. The applications which have not duly been filled in and not having valid Bank Draft towards Earnest Money Deposit (E.M.D) amount shall be liable for rejection.

6. The highest **bid offer** shall be accepted and such applicant shall have to **deposit the full bid amount within 7 (Seven) days from the date of auction sale**. On failure to make payment of the bid offered price / auction sale amount in full, the Earnest Money Deposit (E.M.D) shall be forfeited to the Govt. exchequer. Further, in such case or in the event where highest bidder is unable to deposit the bid amount, the second highest bid offer will be accepted.
7. The vehicle shall not be delivered to the successful applicant/ highest bidder until realization of auctioned/offered amount in full and before completion of requisite formalities. Tools, instruments and spare parts shall not be delivered with the vehicle.
8. The vehicle should be removed from the site **within 7 (Seven) days from the date of final payment of the offered/ auction sale amount in full**. In case the vehicle is / are not removed, the custody and safety of the vehicle (s) shall be the responsibility of the successful bidder. No claim or complain on that account shall be entertained and ground rent at the rate of 1% of bid/negotiated money will be charged for each day or part of the day till the removal of vehicle from the site.
9. The Superintendent of Excise, Jharsuguda reserves the right to accept or reject any or all applications without assigning any reason thereof. The decision of the undersigned is final in case of any dispute.

TERMS AND CONDITIONS

1. The intending applicant/ bidders are to obtain the vehicle list put to auction sale and application **FORM** from the website **jharsuguda.odisha.gov.in** as mentioned in the notice and inspect the seized vehicles kept in different places as mentioned in the vehicle list well in advance before submitting the sealed applications. Submission of sealed application will be taken as sufficient proof of the applicant to have inspected the vehicles put to auction sale and no further complain regarding the condition of the vehicle will be entertained on any circumstance. The auction sale of the seized vehicles are done "as is where is and what ever there is basis condition".
2. The intending applicants/ bidders will have to submit an earnest money of **Rs.1,000/- (One Thousand Rupees)** only, against each of the vehicle in shape of Account Payee Bank Draft in favour of **Superintendent of Excise, Jharsuguda payable at SBI Main Branch, Jharsuguda** along with the application. Application papers without E.M.D in shape of Bank Draft will be rejected. If an applicant wants to apply for more than one vehicle, then he has to apply in separate application form for each vehicle and in separate sealed cover. However, he can deposit the earnest money cumulatively in one Bank Draft in favour of the **Superintendent of Excise, Jharsuguda payable at SBI Main Branch, Jharsuguda**. In this case, all the applications form with cumulatively in one Bank Draft should be submitted in one sealed cover.
3. The applicants/ bidders shall submit their applications accompanied with following documents mentioned herein, namely:-

A copy of Photo I.D. Proof i.e. Aadhaar / Voter ID Card / Driving License & PAN Card.
4. All the applications received will be opened at **11:00 A.M. on dated 29-05-2025**. If the date of opening of application is declared as a Govt. Holiday, the application will be opened on the next working day as per the scheduled time. Delay in postal delivery shall not be taken into account. The applicants/ bidders are requested to superscribe on the sealed cover as "Application for Auction of Vehicle vide Regd No._____". No application will be received by hand.
5. The highest bid offered amount shall be accepted and such applicants shall have to deposit full bid amount/ auction sale amount within 7 days from the date of issue of ratification order or confirmation of the applicant. However, the undersigned reserves the right to allow more time to the applicant, offered highest bid price for payment of the accepted highest bid amount for the interest of the state. The highest bid amount below the reserved upset price and in case of single application received will be referred to the competent authority for his decision/ approval.
6. In case the highest bidder fails to deposit the bid amount within the stipulated period from the date of ratification order/ confirmation of highest bid amount, the EMD amount deposited on the date of opening, of the application will be forfeited to Govt. exchequer and the vehicle will be put to re-auction-sale entirely at the risk of the highest bidder.
7. The vehicle(s) shall not be delivered to the highest bidder/ offered price holder until full payment is made and other formalities are fulfilled.

8. The highest applicants/ bidders shall take delivery and remove the vehicle from the spot within 7 (seven) days from the date of ratification order/ confirmation of the highest bid and full payment of the highest bid amount failing which no claim will be entertained on any circumstance later on and the custody and safety of the vehicle shall be the responsibility of the applicant. Failure to remove the vehicle within the time bar, ground rate at the rate 1% of the highest bid/ negotiated amount will be charged for each day or part of the day till removal of the vehicle from the site.
9. Since these are seized vehicles and seized for violation of Excise Act and rule, the transfer of ownership of the vehicles will be made on deposit of requisite fees for transfer of ownership and submission of proper application form and other required documents within 7 days of the date of Auction sale by the auction purchaser. The responsibility shall lie with the winner to get record of the ownership of the vehicle in his name.
10. No one except the applicants or their authorized representative shall be allowed at the time of opening of sealed applications.
11. Applications shall not be accepted after the stipulated period.
12. In case of any complain/ objection or claim relating to the auction sale is raised, then the decision of the undersigned shall be conclusive.
13. The undersigned reserves the right to accept or reject any or all the auction sale without assigning any reason thereof
14. Any litigation/dispute on this auction sale shall be subject to the jurisdiction of Jharsuguda District only.
