PUBLIC AUCTION NOTICE

It is hereby notified that open public auction for 109 (One Hundred Nine) numbers of different sizes of old stainless-steel hand railings i.e., (Length of (5 to 6 mtrs)= 06 numbers, (4 to 5 mtrs) = 15 numbers, (3 to 4 mtrs) = 07 numbers, (2 to 3 mtrs) = 69 numbers and (1 to 2 mtr) = 12 numbers) removed from the Verandas of New District Court Complex, Jharsuguda and kept inside the Old District Court Complex, Jharsuguda will be conducted on **20.12.2025** at about **12.00 Noon** in the Old District Court Premises, Jharsuguda. Interested bidders/buyers are requested to remain present and participate in the auction on the schedule date, time and place mentioned above along with their identity proofs.

Terms and Conditions

1. Interested bidders must deposit **non-returnable "entry fee" @ Rs. 500/-** (Rupees Five Hundred only) **in cash** in the Process Establishment Section, Civil Courts, Jharsuguda on **20.12.2025 between 10 AM to 11 AM** before entering into the auction.
2. All the participating bidders are required to fill up bidder information sheet and produce copy of **Aadhar Card** as address proof at the time of auction.
3. The Open Public Auction sale will be held on the date fixed i.e on **20.12.2025 from 12.00 Noon** onwards in the Old District Court Building premises, Jharsuguda.
4. Sale will be confirmed in the name of **Highest Bidder (H1 Bidder)** unless the **Judge-in-Charge of the Process Establishment Section, Civil Courts, Jharsuguda** thinks that the bid offered is grossly inadequate in which case property will be put to sale again.

5. The successful bidder in the auction shall have to deposit 25% of the bid amount and applicable GST in shape of Bank Draft drawn in favour of Registrar, Civil Courts, Jharsuguda and rest amount shall have to pay on the next working day positively. Thereafter, the auctioned items will be handed over to such bidder.
6. The successful bidder in the auction must lift the auctioned items handed over to him within **02(Two) working days** from the date of full payment.
7. Once the bid is over and delivery is taken, the successful bidder shall be solely responsible for lifting and transporting the materials on an “**As is where is**”, “**As is what is**”, and “**no complaint and “Caveat Emptor”**” basis. No refund or return of materials will be entertained after possession has been taken.
8. The transportation and loading and unloading charges of the auctioned items shall be borne by the H1 bidder.
9. No officers or employees of the Court can participate in the auction of the items.
10. If the auctioned amount is not paid by the successful bidder within the stipulated time, the Authority reserves right to resale the property.
11. The interested bidders/buyers may physically visit the Store and inspect the articles to be auctioned from **15.12.2025 to 19.12.2025** between **01.00 PM to 02.30 PM** on working days before participation in the Auction.
12. The **Base Price (Up-set Price)** of old stainless-steel hand railings is fixed at **Rs. 172/- Kg excluding GST**. GST will be applicable on sale value as per the Government rule.
13. The Authority reserves the right to cancel the auction process at any stage without assigning any reason thereof.

14. In case of any dispute, the decision of the District Judge, Jharsuguda shall be final and binding.
