- 2) **The Bidders should deposit online 1 % Bid Security / EMD of tender cost as per Letter of Works Department.**
- 3) The Bid documents will be available in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from 18:00 Hours of 19.12.2025 to 18:00 Hours of 27.12.2025.
- 4) The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
- 5) **Bids shall be received only "On-line"** on or before 18:00 Hours of Dtd.27.12.2025.
- 6) Bids received "on-line" shall be opened at 11:30 Hours on dt. 29.12.2025 in the office of the Divisional Forest Officer, Jharsuguda K.L. Division, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging in to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- 7) The items covered in **Clause No-122 of DTCN** for roads and building works are required as essential criteria for eligibility for qualification, Checklist should be duly filled in.
- 8) The bidder shall transfer online the cost of bid documents as shown in **column-7** above through a process as mentioned in DTCN.
- 9) Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
