**REVISED ORDER**

In continuation of this office Order No. 7482/RTA, dated 30.12.2025, and whereas, in connection with the Jharsuguda Zilla Mahotsav "DULDULI-2026", scheduled to be held from 01.01.2026 to 05.01.2026 at BTM Ground, Jharsuguda, large-scale public gatherings and similar activities are expected, particularly during evening and night hours which are likely to cause traffic congestion and may increase to law-and-order situations within the Jharsuguda town area.

Now, therefore, in partial modification of the aforesaid order, and in view of the safety and convenience of the general public and to safeguard public and private property, and in exercise of the powers conferred under Section 115 of the M.V.Act 1988, I, **Shri Kunal Motiram Chavan, IAS, Collector & District Magistrate, Jharsuguda**, do hereby order the following revised traffic restrictions:

1. Movement of all buses shall be restricted in the specified areas during the period from **01.01.2026 to 05.01.2026 (from 3.00 PM to 6.00 AM)**.
2. All buses passing through Jharsuguda town shall be diverted through the bypass route via **DPO Chowk – Talpatia Chowk** and shall not be permitted to pass through the town area/near the **DULDULI Mahotsav venue during the above period**.
3. All bus operators are hereby directed to strictly adhere to the above diversion and restriction arrangements during the above period.
4. The enforcement of this order shall be carried out in coordination with the IIC, Airport Police Station, Jharsuguda, to prevent traffic congestion and to ensure the smooth and safe conduct of the Mahotsav.

Any violation of this order shall be viewed seriously and shall be dealt with in accordance with the provisions of the M.V.Act, 1988 and the rules made thereunder.

This revised order shall come into force with effect from **01.01.2026 to 05.01.2026**.


