Terms and conditions :-

- 1 The cost of bid documents (non-refundable) mentioned in column No. 5 & EMD in column No.6 should be deposited in shape of cash/demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Brajrajnagar Municipality payable at Brajrajnagar.
- 2 The bidder should have Voter Id Card, Aadhar Card, GST Registration Certificate (if any), PAN Card. No undertaking would be allowed against non-submission of any required document.
- 3 The bidder has to specify the nature of business he/she intend to do. Further business of Liquor, explosives, hazardous substances will not be permitted.
- 4 The minimum Security Deposit will be Rs.10,000/-(Rupees Ten Thousand) only.(Gndhi Chack,Infront of R.I Office & Khaliakani Vending Zone stall) Rs.8,000.00(Rupees Eight Thousand) (Laxmi Mandir Chack & IB pit Vending zone stall) & Rs.6,000.00(Rupees Six thousand) Kalinagar vending zone stall.The bidder quoting maximum price as Security, will become the successful bidder. In case of multiple bidder quoting same price, successful bidder will be chosen by transparent lottery system.
- 5 Security Deposit of the quoted price has to be deposited by the bidder in shape of cash/demand draft/Banker's cheque only from any nationalized Bank drawn in favour of the Executive Officer, Brajrajnagar Municipality payable at Brajrajnagar within 7 days from declaration of successful bidder failing which allotment will be cancelled. & EMD will be forfeited.
- 6 The rent of the vending zone stall will be Rs.500/- (Rupees Five hundred) for only per month and the successful bidder has to pay rent by 5th of every month.
- 7 Internal Electrification and the power connection has to be taken by the successful bidder after allotment.
- 8 In case the stall keeper desires to vacate the vending zone stall, he/she can vacate the same within 02(Two) months prior notice so that his Security Deposit will be returned back.
- 9 No successful bidder will be allowed to Sub-let the vending zone stall to anybody in any circumstances without prior permission of undersigned. Sublet will result immediate cancellation of grant of license after due verification.
- 10 The rent will increase 10% in every year or any rate decided by Council/ State Govt. time to time.
